GENERAL COURSE INFORMATION

COURSE DESCRIPTION

This course is a study of physics, mathematics, chemistry, and basic microbiology as it relates to respiratory care.

STUDENT LEARNING OUTCOMES

Students will:

- 1. Apply basic mathematic concepts related to respiratory care.
- 2. Apply concepts of chemistry related to respiratory care.
- 3. Apply concepts of physics related to respiratory care.
- 4. Apply basic microbiology concepts related to respiratory care

COURSE OBJECTIVES - Outline form (correlated to Scans and Foundations Skills)

- 1. The student will perform basic computations to calculate the answers to basic chemistry, physics, and statistics problems. (F-3)
- 2. The student will approach practical respiratory chemistry, physics, and statistics problems by choosing appropriately from a variety of mathematical techniques. (F-4)
- 3. The student will understand the theory of gas laws, and exhibit this by recognizing problems in alterations of temperature, pressure, and volume, and devising a plan of action by calculating expected changes. (F-9)
- 4. The student will recognize quality control problems in the blood gas laboratory, and devise a plan of action to solve those problems. (F-8, F-9, C-5, C-6, C-7, C-16, C-20)
- 5. The student will utilize symbols, pictures, and graphs to aid in discussing respiratory science principles. (F-10)
- 6. The student will discuss the atomic structure and electron configuration. (F-10)

EVALUATION METHODS

- 1. Four unit examinations will be given during the semester, followed by a comprehensive final examination. Make-up exams will not be given. Students will be allowed to drop their lowest unit exam grade.
- 2. A comprehensive final examination will be given.
- 3. Pop guizzes may be given in class.
- 4. Homework may be assigned during the semester.

ACADEMIC INTEGRITY

ATTENDANCE POLICY

Students are expected to attend all classes in order to be successful in a course. The student may be administratively withdrawn from the course when absences become excessive as defined in the course syllabus.

When an unavoidable reason for class absence arises, such as illness, an official trip authorized by the college, or an official activity, the instructor may permit the student to make up the work missed. It is the student's responsibility to

complete work missed within a reasonable period of time as determined by the instructor. Students are officially enrolled in all courses for which they pay tuition and fees at the time of registration. Should a student, for any reason, delay in reporting to a class after official enrollment, absences will be attributed to the student from the first-class meeting date.

Students who enroll in a course but have "Never Attended" by the official census date, as reported by the faculty member, will be administratively dropped by the Office of Admissions and Records. A student who does not meet the attendance requirements of a class as stated in the course syllabus and does not officially withdraw from that course by the official census date of the semester, may be administratively withdrawn from that course and receive a grade of "X" or "F" as determined by the instructor. Instructors are responsible for clearly stating their administrative drop policy in the course syllabus, and it is the student's responsibility to be aware of that policy.

It is the student's responsibility to verify administrative drops for excessive absences through MySPC using his or her student's online account. If it is determined that a student is awarded financial aid for a class or classes in which the student never attended or participated, the financial aid award will be adjusted in accordance with the classes in which the student did attend/participate and the student will owe any balance resulting from the adjustment.

he/she has more Regular attendance is necessary to successfully meet the course objectives. The student is responsible for all class work covered during absences from class. Students are expected to be in class, on time. A student is tardy if he/she arrives more than 5 minutes after class begins. If a student is tardy to class three times, it will be counted as one absence. It is the student's responsibility to inform the instructor of the reason for an absence and to do so in a timely fashion. A student may be administratively withdrawn from the course if than <u>5</u> absences from class and the instructor determines the student is unable to successfully meet the course objectives. Students who are tardy are asked to respect their peers and enter the classroom quietly in order not to disrupt the class. Students who are late to a class starting with an examination <u>will not</u> be given additional time to complete the exam. A student's work schedule is not an excuse for missing classes.

COMPUTER USAGE

As computer technology in the field of health occupations continues to become more popular, computers will be used in this course for several assignments. All students have access to computers and printers on the South Plains College campus. Students will be expected to utilize computers to access assignments and classroom resources. All registered students are supplied with a working email account from South Plains College. In order to take exams, students must have their username and password.

PROCTORIO

This course uses a tool called Proctorio. Proctorio is a remote proctoring service software that works within your web browser to confirm student identity and monitor students taking quizzes/exams.

Before Using Proctorio

- In order to use Proctorio, you must have a basic webcam or built-in camera with a microphone enabled on your laptop or desktop computer.
- You must have the Chrome browser on your computer. Download Chrome.
- You must install the Proctorio Chrome extension (Links to an external site.).

- Check the <u>Proctorio Minimum System Requirements (Links to an external site.)</u> to ensure Proctorio will work on your computer.
- You may be required to show a government or school-issued ID if your instructor is requiring Proctorio for any quizzes/exams.

Proctorio FAQs

Q: Can I listen to music while taking the exam?

A: Please refrain from doing so; if there are high noise levels, your exam will be flagged.

Q: Is someone watching me take the test since it is proctored (via Proctorio)?

A: Absolutely not! Although you are being recorded while taking the quiz/exam, the instructor is the only one who has access to your quiz/exam attempt.

Q: What if I have to get up to use restroom during the quiz/exam?

A: Similar to on-site exams, this is highly discouraged! If you MUST leave the room, please send your instructor a message (Remind app or via text) letting them know that your quiz/exam attempt might be "flagged." Please do your best to plan ahead and "go" before beginning the quiz/exam!

Q: Can I take the quiz/exam from any location?

A: Traditional Students will be required to complete their exams at the Reese campus unless otherwise notified.

Distance Learners will be required to complete their exams at their sponsored facility in a designated area.

ASSIGNMENT POLICY

Four assignments may be given to allow students to practice mathematical calculations and concepts before the examinations. Assignments are due at the time of that unit exam and are listed in the class schedule. <u>No late</u> assignments will be accepted.

For students who score less than 80% on their course average, it is highly recommended to attend study lab until the student's course average is 80% or higher for the course. The student can schedule an appointment with the instructor of record for specific remediation instructions which may include exam review, assignment, and relevant course work review.

A home test is sufficient but students must submit a photo of the positive result. The date of the test must be written on the test result and an ID included in the photo. If tested elsewhere (clinic, pharmacy, etc.), please submit a copy of the doctor's note or email notification. Results may be emailed to DeEtte Edens, BSN, RN at dedens@southplainscollege.edu.

A student is clear to return to class without further assessment from DeEtte Edens, BSN, RN if they have completed the 5-day isolation period, symptoms have improved, and they are without fever for 24 hours without the use of fever-reducing medication.

Students must communicate with DeEtte Edens, BSN, RN prior to their return date if still symptomatic at the end of the 5-day isolation.
